Having a global, flexible mandate, the Fund will invest at least 80% in equity and equity-related securities in both U.S. and non-U.S. markets, and the remainder in fixed income securities, including corporate and sovereign debt, in both U.S. and non-U.S. markets. The Fund's portfolio manager is Chuck Clough. As of December 31, 2022 the Fund had approximately \$267.4 million in total assets.
